

## **Minutes of Meeting to discuss Action Plan for this winter season with Industrial Stakeholders**

**October 09, 2019**

A meeting with industrial stakeholders to discuss action plan for Delhi NCR during upcoming winter was held on October 09, 2019 at Central Pollution Control Board, Delhi. Meeting was chaired by Member Secretary, CPCB. The list of participants is annexed.

Member Secretary, CPCB welcomed the participants and emphasized on need for proactive actions by concerned agencies to control air pollution in the industrial areas. A brief presentation was made on issues relating to air quality in the 18 identified priority industrial areas in Delhi-NCR (list enclosed). It was informed that unpaved roads, industrial emissions and waste burning, and heavy commercial vehicles are major sources of pollution in these areas.

After deliberation, following plan of action was decided:

1. Micro level- area specific action plan w.r.t. unpaved roads, dumping of waste, and heavy vehicles along with a timeline (in a tabular form) shall be made by the agencies and provided to concerned SPCBs and CPCB.
2. A mechanism may be setup for coordinated actions by concerned agencies, industries association and other stakeholders. Respective State Pollution Control Boards may act as Nodal Agency.
3. Carrying out joint day and night patrolling and monitoring in high emission/priority areas on a regular basis by SPCBs and concerned agencies
4. SPCBs to individually hold regular interactions with stakeholders in respective industrial areas and ensure that necessary actions are taken on ground to control air pollution.
