 - ii. You shall ensure that collection mechanism or centre are set up or designated as per the details given in the Extended Producer Responsibility plan and that shall be completed before the proposed dates if any in the EPR Plan.

- iii. You shall ensure that all the collected e-waste is channelized to your authorised dismantlers/recyclers namely M/s. Auctus E- Recycling Solutions Pvt. Ltd., A-58, Udyog Kendra, Vill. Habibpur, Noida, Dadri Road, Greater Noida, M/s. Namo E- Waste Management Limited 14/1 Mile Stone Mathura Road, Faridabad- 121003 and M/s. Ramky Enviro Engineers Limited, Ramky Towers, Ramky Grandiose, Ramky Tower, Gachibowli, Hyderabad and records shall be maintained both at recyclers end as well as at your end.
- iv. You shall ensure that your Producer Responsibility Organizations (PROs) namely M/s. Auctus E- Recycling Solutions Pvt. Ltd., A-58, Udyog Kendra, Vill. Habibpur, Noida, Dadri Road, Greater Noida, M/s. Namo E- Waste Management Limited 14/1 Mile Stone Mathura Road, Faridabad- 121003 and M/s. Sahaas Waste Management Pvt. Ltd., #21, Ground Floor, 5th C Cross Road, MCHS Colony, 16th Main, BTM Layout, 2nd Stage, Bengaluru follow all the clause mentioned in their Agreements.
- v. You shall maintain records in Form-2 of these Rules, of e-waste and make such records available for scrutiny by Central Pollution Control Board as and when directed
- vi. You shall file annual returns in Form-3 to the Central Pollution Control Board on or before 30th day of June following the financial year to which that returns relates. (The List of collection centre/collection points, names of PROs and toll free number for reverse logistics)

vii. General Terms & Conditions of the Authorisation:

- a. The authorisation shall comply with provisions of the Environment (Protection) Act, 1986 and the Rules made there under;
- b. The authorisation or its renewal shall be produced for inspection at the request of an officer authorised by the Central Pollution Control Board;
- c. Any change in the approved Extended Producer Responsibility plan should be informed to Central Pollution Control Board within 15 days on which decision shall be communicated by Central Pollution Control Board within sixty days;
- d. It is the duty of the authorised person to take prior permission of the Central Pollution Control Board to close down any collection centre/points or any other facility which are part of the EPR plan.
- e. An application for the renewal of authorisation shall be made as laid down in sub-rule (vi) of rule of 13(1) the E- Waste (Management) Rules, 2016;
- f. The Central Board reserves right to cancel/amend/revoke the authorisation at any time as per the policy of the Central Board or as notified by the Government from time to time.

viii. Additional Conditions:

- a. Whenever RoHS sampling and testing will be carried out by CPCB, you have to bear the cost of equipment— Television Sets (including sets based on LCD, LED Technology and CRT) (CEEW1), Refrigerator (CEEW2), Washing Machine (CEEW3) and Air conditioners excluding centralised air conditioning plants (CEEW4) as and the cost of testing as per Rule 16 (9) of the E-Waste (Management) Rules, 2016;
- b. That the applicant will submit revised application for grant of EPR Authorization in case of applicant changing its EPR Plan;
- c. You have to submit to CPCB every quarter the amount (in number or weight) of e-waste of EEE Code - CEEW1, CEEW2, CEEW3 and CEEW4, collected in that quarter and recycled;
- d. You have to maintain all the technical documentation on RoHS for verification by CPCB/SPCB whenever required;
- e. In case of any violation of the above condition, your authorization will be suspended/cancelled.
