2. M/s. Rank Office Automation (P) Ltd., 14 Ansari Market, Daryaganj, New Delhi-110002 is hereby granted Extended Producer Responsibility - Authorisation based on:

(a) Extended Producer Responsibility plan and;

(b) Proposed target for collection of E-waste submitted by them.

M/s. Rank Office Automation (P) Ltd. shall meet the yearly collection target for e-waste as per the table below:

3. The Authorisation shall be valid for a period of five (5) years from the date of issue with following conditions:

- You shall strictly follow the approved Extended Producer Responsibility Plan, a copy of which is enclosed herewith as Enclosure-I
- You shall ensure that collection mechanism or collection centres are set up or designated as per the details given in the Extended Producer Responsibility Plan and that shall be completed before the proposed dates if any in the EPR Plan. (List of collection centres and Toll free no. is enclosed)

- iii. You shall ensure that all the collected e-waste is channelized to your authorised recyclers/ dismantlers M/s. 3R recycler, having dismantling facility located at Plot No. 266, sector – 8, IMT Manesar, Gurgaon, Haryana – 122052 and PRO's authorised recyclers/ dismantlers that are M/s. E-R3 Solutions Private Limited, C-430, 1st Cross, Behind Peenya Police Station 1st Stage, Peenya Industrial Area, Peenya, Bangaluru, M/s. Eco Friendly Metals Private Limited, Plot No. A-7, Industrial Estate No.1, Near M.R. Faridabad, Haryana and M/s. ECS Environment Pvt. Ltd., ECS house 11 &12, Garden View, opp. Auda Garden, Sindhubhav Road, Off SG Highway, Bodakdev, Ahmedabad 380059 and records shall be maintained both at recyclers end as well as at your end.
- iv. You shall maintain records, in Form-2 of these Rules of e-waste and make such records available for scrutiny by Central Pollution Control Board as and when directed;
- v. You shall file annual returns in Form-3 to the Central Pollution Control Board on or before 30th day of June following the financial year to which that returns relates;

vi. **General Terms & Conditions of the Authorisation:**

- a. The authorisation shall comply with provisions of the Environment (Protection) Act, 1986 and the E-waste (Management) Rules, 2016 made there under;
- b. The authorisation or its renewal shall be produced for inspection at the request of an officer authorised by the Central Pollution Control Board;
- c. Any change in the approved Extended Producer Responsibility plan should be informed to Central Pollution Control Board within 15 days on which decision shall be communicated by Central Pollution Control Board within sixty days;
- d. It is the duty of the authorised person to take prior permission of the Central Pollution Control Board to close down any collection centre/points or any other facility which are part of the EPR plan.
- e. An application for the renewal of authorisation shall be made as laid down in sub-rule (vi) of rule of 13(1) the E- Waste (Management) Rules, 2016;
- f. The Central Board reserves right to cancel/amend/revoke the authorisation at any time as per the policy of the Central Board or as notified by the Government from time to time.

**vii. Additional Conditions:**

- a. Whenever RoHS sampling and testing will be carried out by CPCB, you have to bear the cost of equipment – Copying Equipment (ITEW7) and the cost of testing as per Rule 16 (9) of the E-Waste (Management) Rules, 2016;
- b. That the applicant will submit revised application for grant of EPR Authorization, in case it will engage any other PRO or change its EPR Plan;
- c. That the applicant has to ensure that e-waste collected at collection centres through collection schemes i.e DRS and Buy back and through reverse logistics of PRO mentioned in the application should reach to its PRO's authorized dismantler/recycler as well as its own authorized dismantler/recycler;
- d. That the applicant has to ensure that its PRO carry out all the activities as agreed upon between the applicant and the PRO for implementing the EPR Plan;
- e. That the applicant has to submit to CPCB every quarter the amount of (in number or weight) of e-waste of EEE Code –ITEW 7 collected in that quarter and recycled;
- f. That the applicant has to maintain all the technical documentation on RoHS for verification by CPCB/SPCB whenever required;
- g. In case of any violation of the above condition, your authorization will be suspended/cancelled;
