- 2. M/s. Shiv Shakti International, 4/54, Brij Mohan Marg, Behind Ram Mandir, Daryaganj, New Delhi- 110 002 is hereby granted Extended Producer Responsibility Authorisation based on:
  - (a) Extended Producer Responsibility plan and;
  - (b) Proposed target for collection of E-waste submitted by them.

M/s. Shiv Shakti International, shall meet the yearly collection target for e-waste as per the table given below:

- 3. The Authorisation shall be valid for a period of five (5) years from date of issue with following conditions:
  - i. You shall strictly follow the approved Extended Producer Responsibility plan, a copy of which is enclosed herewith as Enclosure-I;
  - ii. You shall ensure that collection mechanism or centres or points are set up or designated as per the details given in the Extended Producer Responsibility plan and that shall be completed before the proposed dates if any in the EPR Plan (list of collection points and the toll free numbers for reverse logistics enclosed);

- iii. You shall ensure that all the collected e-waste is channelized to your authorised dismantler/recycler M/s. 3R recycler, Plot No. 266, sector 8, IMT Manesar, Gurgaon (Haryana) 122052 and records shall be maintained both at recyclers end as well as at your end:
- iv. You shall maintain records, in Form-2 of these Rules, of e-waste and make such records available for scrutiny by Central Pollution Control Board as and when directed;
- v. You shall file annual returns in Form-3 to the Central Pollution Control Board on or before 30th day of June following the financial year to which that returns relates.

#### vi. General Terms & Conditions of the Authorisation:

- a. The authorisation shall comply with provisions of the Environment (Protection) Act, 1986 and the E-waste (Management) Rules, 2016 made there under;
- b. The authorisation or its renewal shall be produced for inspection at the request of an officer authorised by the Central Pollution Control Board;
- c. Any change in the approved Extended Producer Responsibility plan should be informed to Central Pollution Control Board within 15 days on which decision shall be communicated by Central Pollution Control Board within sixty days;
- d. It is the duty of the authorised person to take prior permission of the Central Pollution Control Board to close down any collection centre/points or any other facility which are part of the EPR plan.
- e. An application for the renewal of authorisation shall be made as laid down in sub-rule (vi) of rule of 13(1) the E- Waste (Management) Rules, 2016;
- f. The Central Board reserves right to cancel/amend/revoke the authorisation at any time as per the policy of the Central Board or as notified by the Government from time to time.

#### vii. Additional Conditions:

- a) Whenever RoHS sampling and testing will be carried out by CPCB, you have to bear the cost of equipment Copying Equipment (Used Multifunction Device) (ITEW7) and the cost of testing as per Rule 16 (9) of the E-Waste (Management) Rules, 2016;
- b) That the applicant will submit revised application for grant of EPR Authorisation in case of applicant engaging any PRO or changing its EPR Plan;

 You have to ensure that the e-waste collected at collection points or through take back mechanism mentioned in the application should reach to your authorized dismantler/recycler;

d) You have to submit to CPCB every quarter the amount (in number or weight) of e-waste

of EEE code - ITEW7 collected in the quarter and recycled;

e) You have to maintain all the technical documentation on RoHS for verification by CPCB/SPCB whenever required;

f) In case of any violation of the above condition, your authorization will be suspended/cancelled.
