You shall ensure that collection mechanism or centre or points are set up or designated as per the details given in the Extended Producer Responsibility plan and that shall be completed before the proposed dates if any in the EPR Plan. The applicant will submit updated list of collection points beyond the present 194 collection point along with Annual Return for the year 2017-18. (List of collection centres and points & the toll free numbers for reverse logistics enclosed);

iii. You shall ensure that all the collected e-waste is channelized to your authorised recycler M/s. Auctus E- Recycling Solution (P) Ltd., A-58, Udyog Kendra-1, Ecotech-3, Habibpur Greater Noida (U.P.) as well as to M/s. Attero Recycling Private Limited, facility at Plot No. 173 Raipur, Bhagwanpur Industrial Area, Roorkee;

iv. You shall maintain records, in Form-2 of these Rules, of e-waste and make such records available

for scrutiny by Central Pollution Control Board;

v. You shall submit sale data for the year 2016-17 for the EEE code ITEW15 (Smart Phone) along with the annual returns in Form-3 to the Central Pollution Control Board on or before 30<sup>th</sup> day of June following the financial year to which that returns relates;

## vi. General Terms & Conditions of the Authorisation:

a. The authorisation shall comply with provisions of the Environment (Protection) Act, 1986 and the E-waste (Management) Rules, 2016 made there under;

b. The authorisation or its renewal shall be produced for inspection at the request of an officer

authorised by the Central Pollution Control Board;

- c. Any change in the approved Extended Producer Responsibility plan should be informed to Central Pollution Control Board.
- d. It is the duty of the authorised person to take prior permission of the Central Pollution Control Board to close down any collection centre/points which are part of their EPR plan.
- e. An application for the renewal of authorisation shall be made as laid down in sub-rule (vi) of rule of 13(1) the E- Waste (Management) Rules, 2016;
- f. The Board reserves right to cancel/amend/revoke the authorisation at any time as per the Policy of the Board or Government.

#### vii. Additional Conditions:

a. Whenever RoHS sampling and testing will be carried out by CPCB, you have to bear the cost of equipment – (Cellular Phones (Smart phones) code ITEW15) as per e-waste Rules, 2016 and the cost of testing as per Rule 16 (9) of the E- Waste (Management) Rules, 2016;

- b. That the applicant will submit revised application for grant of EPR Authorization in case of applicant changing its EPR Plan;
- c. That the applicant has to ensure that e-waste collected at collection centres and points mentioned in the application should reach to its authorized dismantler/recycler;
- d. That the applicant has to ensure that its PRO carry out all the activities as agreed upon between the applicant and the PRO for implementing the EPR Plan;
- e. That the applicant has to submit to CPCB every quarter the amount (in number or weight) of e-waste of EEE code- ITEW 15 (Smart Phone) collected in that quarter and recycled;
- f. That the applicant has to properly maintain all the technical documentation on RoHS for verification by CPCB/SPCB whenever required;
- g. In case of any violation of the above condition, your authorization will be suspended/cancelled.
