## **Minutes of Meeting**

Subject: Minutes of Meeting on Analysis of SMS Report and Offline Industry Data (15th August to 15th September 2017) held on 11/10/2017 at 2<sup>nd</sup> Floor Conference Hall.

A meeting was held on 11<sup>th</sup> Oct 2017 on above mentioned subject and chaired by Chairman, CPCB at 2<sup>nd</sup> Floor Conference Hall. It was attended by Divisional Heads and Senior officers of IPC-I, IPC-II, IPC-III, IPC-IV, IPC-VI and WQM-II.

1. Sh. P.K.Gupta, Divisional Head, IPC VI, presented status of action taken on Inspection Reports (IR) of Industries proposed for inspection based on monthly SMS alert and offline industry lists. He has presented the entire scenario since beginning of this activity.

Discussions were held and following major directions were issued by CCB CPCB:-

- 2. Detail breakup of 99 non complying industries i.e. for how many industries Show cause notice (SCN) were issued and for how many closure notices were issued to be submitted by IPC-VI.
- 3. It was informed by IPC II that there are problems in downloading the Inspection Reports from the portal for which IT Division will provide the solution.

4. All Divisional Heads were directed to provide details of follow up of SCN issued

based on SMS and Offline list data and details for number of cases where given time

limit has crossed. IPC VI to compile and place the information to MS and CCB.

5. All the Divisional Heads will be responsible for any delay of processing reports/files.

6. It was directed that next week onwards there should be no penedency in Inspection

Report processing.

7. CCB suggested all the divisions to analyse the monthly SMS and Offline industry

status list, bring out the outcomes/benefits as a tool. He also suggested to share the

methodology of practice with SPCB officials and involve them in the process as the

same data is also available to them.

8. Sh Aditya Sharma presented overall scenario of 17 category of industries in terms of

Pollution Index, SMS alerts, Offline Industries, progress in connectivity status and

Gap analysis. CCB directed to relate the presentation with performance of overall

OCEMS activity!

9. Divisional Heads to ensure that all the Gaps are to be bridged like if closures were

issued then whether Industry is closed or not, at the same time if power disconnection

was requested then whether disconnection has been done or not.

10.It was directed to IPC VI to arrange a meeting on formulation and utilisation of

Pollution Index prepared to ascertain pollution potential of different categories of

industries.
