3. The Authorisation shall be valid for a period of five (5) years from date of issue with following conditions:

- i. You shall strictly follow the approved Extended Producer Responsibility plan, a copy of which is enclosed herewith as Enclosure-I;
- ii. You shall ensure that collection mechanism or collection Centres are set up or designated as per the details given in the Extended Producer Responsibility plan and that shall be completed before the proposed dates if any in the EPR Plan (list of collection Centres and the toll free numbers for reverse logistics enclosed);
- iii. You shall ensure that all the collected e-waste is channelized to your PRO M/s Swach Enviro E-Waste India Pvt. Ltd. 3rd Floor, H N 13, BLK-PU, Pitampura, North West Delhi, Delhi, 110034 and records shall be maintained at recycler/dismantler and your end;
- iv. You shall maintain records, in Form-2 of these Rules, of e-waste and make such records available for scrutiny by Central Pollution Control Board;
- v. You shall file annual returns in Form-3 to the Central Pollution Control Board on or before 30th day of June following the financial year to which that returns relates.

vi. General Terms & Conditions of the Authorisation:

- a. The authorisation shall comply with provisions of the Environment (Protection) Act, 1986 and the E-waste (Management) Rules, 2016 made there under;
- b. The authorisation or its renewal shall be produced for inspection at the request of an officer authorised by the Central Pollution Control Board;
- c. Any change in the approved Extended Producer Responsibility plan should be informed to Central Pollution Control Board within 15 days on which decision shall be communicated by Central Pollution Control Board within sixty days;
- d. It is the duty of the authorised person to take prior permission of the Central Pollution Control Board to close down any collection centre/points or any other facility which are part of the EPR plan;

- e. An application for the renewal of authorisation shall be made as laid down in sub-rule (vi) of rule of 13(1) the E- Waste (Management) Rules, 2016;
- f. The Board reserves right to cancel/amend/revoke the authorisation at any time as per the policy of the Board or Government.

**vii. Additional Conditions: -**

- a) That the applicant will submit annual sales data along with annual returns;
- b) That the applicant has to ensure that the addresses of collection points provided by them in their EPR Plan are correct and traceable and the collection points/centres are functional;
- c) That the applicant will submit revised application for grant of EPR Authorisation in case of applicant adding/changing PRO or changing its EPR Plan;
- d) That the applicant has to ensure that the e-waste collected at collection centres/points or through Buy-back and DRS mentioned in the application should reach to its authorized dismantler/recycler;
- e) That the applicant has to submit to CPCB every quarter the amount of E-waste (in weight) of EEE code ITEW1 (Minicomputers & Mainframes), ITEW2, ITEW3, ITEW4, ITEW5, ITEW6, ITEW7, ITEW8, ITEW9, ITEW10, ITEW11, ITEW12, ITEW13, ITEW14, ITEW15 (Feature Phones & Smart Phones) and ITEW16, CEEW1, CEEW2, CEEW3 and CEEW4 collected in that quarter and recycled;
- f) That the applicant has to submit Enclosure - A of the self-declaration whenever it launches any new model of its product;
- g) That the applicant has to provide RoHS information on the booklet and brochures of their Products;
- h) That the applicant has to ensure that the Bills/Invoices of sale of EEE have to contain information on toll free number, web site link for collection, channelization of e-waste;
- i) That the applicant has to maintain all the technical documentation on RoHS for verification by CPCB/SPCB whenever required;
- j) That the applicant has to ensure that its PRO named 'M/s Swach Enviro E-Waste India Pvt. Ltd. carry out all the activities as agreed upon between the applicant and the PRO for implementing the EPR Plan;
- k) In case of any violation of the above condition, your authorization will be suspended/ cancelled;
