 - ii. You shall file annual returns in the laid down form on the portal on or before 30th day of June following the financial year to which that returns relates;

iii. The producer shall fulfil their extended producer responsibility obligations through online purchase of extended producer responsibility certificate from only those recyclers having obtained recycler registration certificate from CPCB through the EPR portal and whose name appears as registered recyclers on the EPR portal themselves and submit it online by filing quarterly return;

5. General Terms & Conditions of the Authorisation:

- a. The producer shall comply with provisions of the Environment (Protection) Act, 1986 and the E-waste (Management) Rules, 2022 made there under;
- b. An application for the renewal of registration shall be made before 120 days of expiry of this EPR Registration Certificate;
- c. The Board reserves right to cancel/amend/revoke the registration at any time as per the policy.

6. Additional Conditions: -

- a) That the applicant will submit annual sales data along with annual returns on the portal;
- b) That the applicant has to submit to CPCB every quarter quarterly returns in the laid down form on the portal on or before the end of the month succeeding the quarter;
- c) That the applicant has to submit Enclosure A of the self-declaration whenever it launches any new model of its product
- d) That the applicant has to provide RoHS information on the booklet and brochures of their Products;
- e) That the applicant has to maintain all the technical documentation on RoHS for verification by CPCB/SPCB officials whenever required;
- f) In case of any difference, between the details provided by producer and registered recycler the lower figure shall be considered towards fulfilment of extended producer responsibility obligation of the producer.
- g) In case of any violation of the above condition or violation of the rules provisions, your EPR Registration Certificate will be revoked/cancelled;
- h) Environmental compensation charges as deemed fit will shall be imposed for failing to meet recycling target or any other violation under the E-Waste Rules.
