- An application for the renewal of registration shall be made before 120 days of expiry of this EPR Registration Certificate;

- d) That the applicant has to provide RoHS information on the booklet and brochures of their Products;
- e) That the applicant has to maintain all the technical documentation on RoHS for verification by CPCB/SPCB officials whenever required;
- f) In case of any difference, between the details provided by producer and registered recycler the lower figure shall be considered towards fulfilment of extended producer responsibility obligation of the producer.
- g) In case of any violation of the above condition or violation of the rules provisions, your EPR Registration Certificate will be revoked/cancelled;
- h) Environmental compensation charges as deemed fit will shall be imposed for failing to meet recycling target or any other violation under the E-Waste Rules.
