- ii. You shall ensure that collection mechanism or collection centres/points are set up or designated as per the details given in the Extended Producer Responsibility plan and that shall be completed before the proposed dates if any in the EPR Plan (list of collection centres and the toll free numbers for reverse logistics enclosed);

- iii. You shall ensure that all the collected e-waste is channelized to your authorised dismantler/recycler M/s. ECS Environment Pvt Ltd., ECS house 11 & 12, Garden View, Opp. Auda Garden, Sindhubhav Road, Off SG Highway, Bodakdev, Ahmedabad-380059 and M/s. E-R3 Solutions Private Limited, C-401, 1st Cross, Behind Peenya Police Station 1st Stage, Peenya Industrial Area, Peenya, Bangalore, Karnataka-560058 and M/s. Eco Friendly Metals Private Limited Plot No. A-7, Industrial Estate No. 1, Near M.R. Faridabad, Haryana records shall be maintained both at recyclers end as well as at your end;
- iv. You shall maintain records, in Form-2 of these Rules, of e-waste and make such records available for scrutiny by Central Pollution Control Board as and when directed;
- v. You shall file annual returns in Form-3 to the Central Pollution Control Board on or before 30th day of June following the financial year to which that returns relates;
- vi. You shall submit annual sales data alongwith your annual returns.

vii. General Terms & Conditions of the Authorisation:

- a. The authorisation shall comply with provisions of the Environment (Protection) Act, 1986 and the E-waste (Management) Rules, 2016 made there under;
- b. The authorisation or its renewal shall be produced for inspection at the request of an officer authorised by the Central Pollution Control Board;
- c. Any change in the approved Extended Producer Responsibility plan should be informed to Central Pollution Control Board within 15 days on which decision shall be communicated by Central Pollution Control Board within sixty days;
- d. It is the duty of the authorised person to take prior permission of the Central Pollution Control Board to close down any collection centre/points or any other facility which are part of the EPR plan.
- e. An application for the renewal of authorisation shall be made as laid down in sub-rule (vi) of rule of 13(1) the E- Waste (Management) Rules, 2016;
- f. The Central Board reserves right to cancel/amend/revoke the authorisation at any time as per the policy of the Central Board or as notified by the Government from time to time.

viii. Additional Conditions: -

- a) Whenever RoHS sampling and testing will be carried out by CPCB, you have to bear the cost of equipment –Copying equipment: (Used Multifunction Device) (ITEW7) and the cost of testing as per Rule 16 (9) of the E-Waste (Management) Rules, 2016;
- b) That the applicant will submit revised application for grant of EPR Authorisation in case of applicant engaging any other PRO or changing its EPR Plan;

- c) That the applicant has to ensure that the e-waste collected at collection centres/points or through PRO and through buy-back and DRS scheme mentioned in the application should reach to its authorized dismantlers/recyclers;
- d) That the applicant has to submit to CPCB every quarter the amount of E- Waste (in number or weight) of EEE code – ITEW7 collected in that quarter and recycled;
- e) That the applicant has to ensure that its PRO named "Terrapro" carry out all the activities as agreed upon between the applicant and the PRO for implementing the EPR Plan;
- f) That the applicant has to maintain all the technical documentation on RoHS for verification by CPCB/SPCB whenever required;
- g) In case of any violation of the above condition, your authorization will be suspended/ cancelled.
