1. The project proponents would devise a monitoring plan and submit to State Pollution Control Board so as to continuously monitor air polluting activities.
2. The project proponent will comply and commit for the following during winter months
 - a) For all sites with areas of open ground, developers should follow best practice to prevent dust and other pollutant emissions from being carried outside the boundary.
 - b) All construction and demolition debris shall be stored at the site (and not dumped on the roads or open spaces outside) before they are properly disposed.
 - c) All demolition and construction waste shall be managed as per the provisions of the Construction and Demolition Waste Management Rules 2016.
 - d) The project proponent shall be responsible for collection, segregation of concrete, soil and others and storage of construction and demolition waste generated, as directed or notified by above rules.
 - e) Construction site shall be adequately barricaded before the construction begins till the end of operation.
 - f) All material-load entering and leaving sites to be covered.
 - g) Minimize dust generating activities and ensure use of dust suppressant and Anti-Smog Gun, wherever applicable.
 - h) Minimize movement of construction traffic around site
