Sir,

Please refer to the information submitted by you vide e-mail date 15.02.2017, 01.03.2017 and 12.06.2017 to CPCB Delhi, wherein it is informed that due to low demand of the product and others unavoidable circumstances the production process in both 100 TPD kiln was stopped since July'2016.

Further, it is to inform you that CPCB, RD-Kolkata found your unit under shutdown condition on 03.11.2017 and inspection in operating condition could not be carried out. Therefore, you are required to inform CPCB, ensure continuous data transmission from online emission and effluent monitoring systems to CPCB and SPCB before re-starting operation and operate only with valid consent under the Water (Prevention and Control of Pollution) Act, 1974, the Air (Prevention and Control of Pollution) Act, 1981, & Authorization under H&OW (M&TBM) Rules, 2016.
